You'll need to carry both your myki and a valid Pensioner Concession Card in order to access Free Weekend Travel, this is issued on a free myki and gives you travel in any two adjacent zones in Victoria.

If you're a pensioner from another state or territory you're not eligible for Free Weekend Travel. You can, however, travel on public transport in Victoria with a concession fare.

Your personal information, provided by you or generated using the card, is collected by public transport authorities to issue and administer the card. If you don't provide the information required, we may not be able to provide you with a free myki card and weekend travel entitlement.

Your personal information may be used or shared amongst public transport authorities for the operation of myki; to verify entitlement to concession travel; for ticketing enforcement; in emergencies; otherwise as required or authorised under law; or with your consent. You'll be able to access your personal information.

Your myki is issued subject to, and its use is governed by, the myki Terms of Use, the Transport (Compliance and Miscellaneous) Act (1983) and related regulations, and the Victorian Fares and Ticketing Manual (myki) ('Ticket Conditions'), as amended from time to time. The myki Terms of Use limit Public Transport Victoria's (PTV) liability and may impose certain fees.

Privacy

Public Transport Victoria (PTV) understands and respects your right to privacy and is committed to privacy protection. The Privacy and Data Protection Act 2014 and PTV's Privacy Policy regulate how we collect and handle your personal information.
